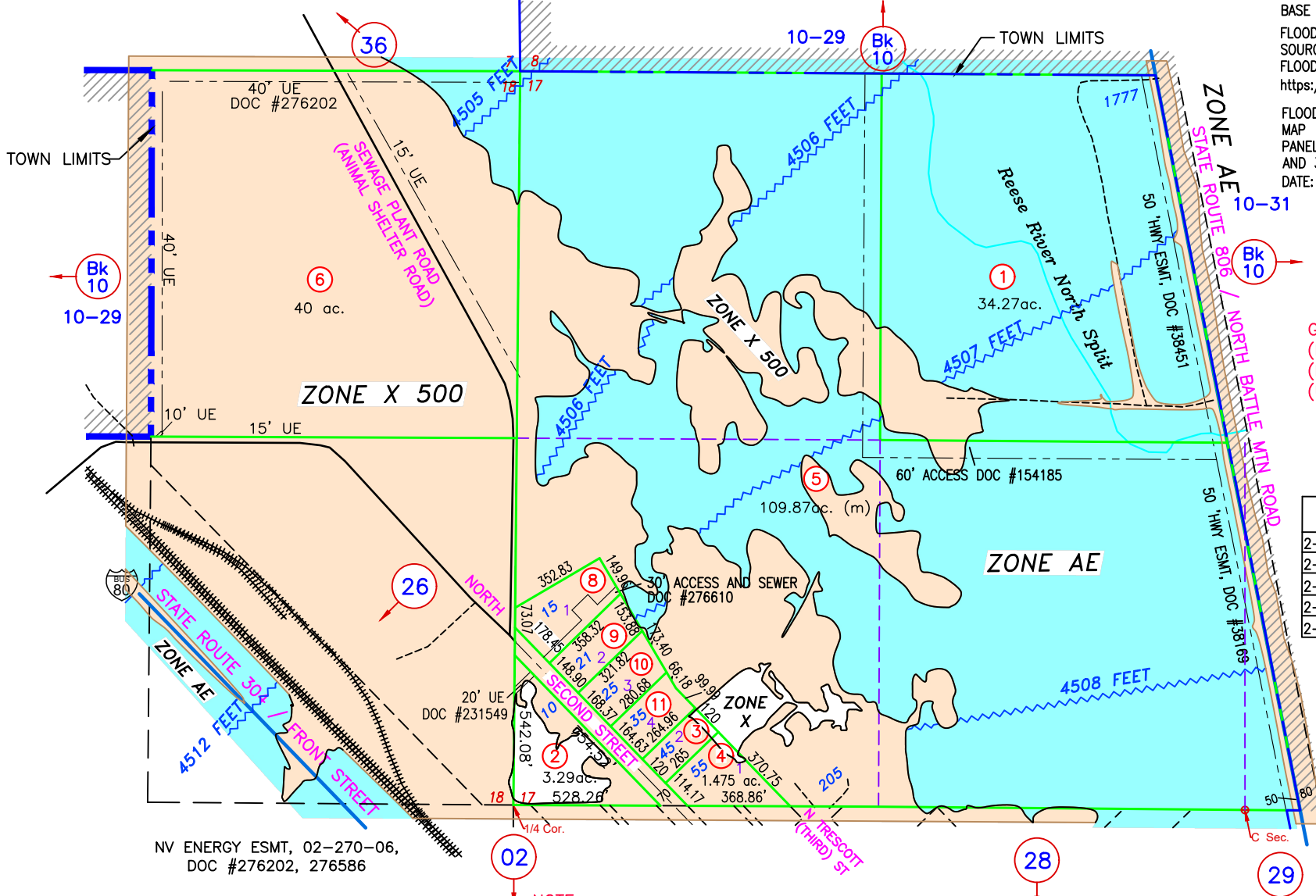


02-27 FLOOD ZONE MAP

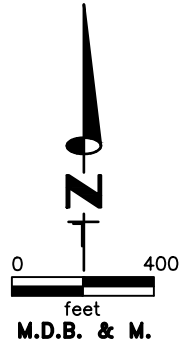
